PRE-QUALIFICATION CRITERIA

For pre-qualification, suppliers must meet the minimum score for each criterion:

- Relevant Experience
- Personnel Resources
- Financial Capacity
- Equipment Resources e.g. warehouses (where applicable)
- Environment, Health and Safety
- Industry Background (where applicable)

ELIGIBILITY OF SUPPLIERS

To be eligible, suppliers wishing to be pre-qualified must:

- Be able to legally conduct business in the Republic of Trinidad and Tobago;
- Possess the legal capacity to enter into procurement contracts;
- Be compliant with the laws of the Republic of Trinidad and Tobago with regard to its obligations to the BIR, VAT and NIS;
- Not have a history of litigation awards or successful prosecutions against it.

PAYMENT

Pre-qualification documents can be collected upon payment of a non-refundable fee of \$200.00. Payment can be made at any branch of First Citizens Bank - NGC Account #1380545 (Company Name and Contact Number should be inserted on all bank receipts).

INVITATION DOCUMENTS

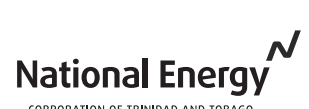
