Steps for pre-qualification:

## **VENDOR SAP ARIBA REGISTRATION**

- Vendors' applications for registration must be approved before making an application for pre-qualification. Vendors with pending applications must submit their Ariba online registration questionnaire and obtain approval via Ariba before applying for pre-qualification.

  Vendors interested in providing the services to The NGC Group are required to send by the closing date noted below a request for pre-qualification for the category of interest
- via email to vendormanagement@ngc.co.tt.
- The fully completed SAP Ariba online registration questionnaire with relevant supporting documents must be uploaded within fourteen (14) days after receiving an invitation to register.
- Vendors who have completed the online Ariba Registration process or are already registered with The NGC Group of Companies can proceed to step B.

Upon successful completion of the Registration (A) above, Registered Vendors are required to pay at any First Citizens Bank: NGC Account # 1380545, a non-refundable fee of TT\$200.00 in their company's name for each service for which they have indicated an interest in pre-qualification. The name of the service category should be written on a copy of the bank receipt and attached in Section 4, "Payment Fee" of the Pre-Qualification Questionnaire in Ariba.

## **B. SUBMISSION OF PRE-QUALIFICATION DOCUMENTS**

The fully completed SAP Ariba online pre-qualification questionnaire(s) with relevant supporting documents must be uploaded within fourteen (14) days after receiving an invitation to pre-qualify. A list of documents to be submitted can be accessed by scanning the **QR code.** 

## PRE-QUALIFICATION CRITERIA

Pre-qualification will be based on the Vendor satisfying the minimum score for each criterion:

- SAP Ariba Online Registration
- Relevant Experience Personnel Resource
- Financial Capacity
- **Equipment Resource**
- Health, Safety, Environment and Security (where applicable)
- Industry Background (where applicable)
- Completion of NGC's Green Agenda Questionnaire (Environmental Management Survey)
- Completion of the Energy Chamber's Local Content Management Assessment

Interested parties seeking to provide goods and services to The NGC Group of Companies must be registered and prequalified with the Procurement Depository as established by Section 26 (1) of the Public Procurement and Disposal of Public Property Act (2015) effective Wednesday 26th April 2023.

Effective 1st January 2023, all contractors and suppliers previously pre-qualified with any member company will now be considered pre-qualified with The NGC Group for all their prospective pre-qualified services.

The closing date for expression of interest to pre-qualify is 7th August 2023.
