The signing of the GSC contract was held recently at NGC's offices at Point Lisas, further securing one of NGC's trusted partnerships and underscoring the synergy between the companies in working to maintain the sustainability of the petrochemical sector. Lisas. The company also operates a gas turbine power generation plant. Commenting on the agreement with TRINGEN, NGC President, Mr. Mark Loquan relayed that, "NGC is pleased to have completed this agreement as it affirms our commitment as the aggregator of gas and to providing support to the petrochemical sector in Trinidad and Tobago."
